#### INTRODUCTION

The Senate is a supreme national Institution with legislative power holding the oversight duty, providing recommendations to text legislation and playing coordinating role between the National Assembly and the Royal government

For the past ten years, as one part of the Legislative Branch of Cambodia, the Senate has been actively taking part in strengthening the rule of law, developing the process of social democratization aimed at ensuring socio-economic development and protecting the general interests of the commune councils throughout the country as well as the interests of citizen from all walks of life.

In particular, the Senate has contributed substantially to government's priority reform and the integration of Cambodia into regional and international framework.

#### I- HISTORICAL BACKGROUND OF THE SENATE

The Bicameral System was established in Cambodia since 1947 when the first Constitution of the Kingdom of Cambodia was enacted. However, due to the impact of the world's cold war, Cambodia had plunged into a protracted war for more than two decades which resulted in the total destruction of social infrastructure at ground zero during the darkest reign of Democratic Kampuchea Regime.

The October 23, 1991 Paris Peace Accord determined to have free and fair general elections in Cambodia was organized by the United Nations

Transitional Authority in Cambodia (UNTAC) to end the conflict and to build the State Governing Institutions and the Rule of Law.

After the first general election held on May 25-28, 1993, a Constitutional Assembly was created on June 14, 1993 with a duty to draft the Constitution of the Kingdom of Cambodia. The Constitution was enacted on September 23, 1993 and took effect on September 24 of the same year. The Constitution defines that the Kingdom of Cambodia is a Constitutional Monarchy.

The governing power of the country was separately divided into three different branches- the Executive, the Legislative and the Judiciary. When the Constitution came into effect, the Constitutional Assembly became the First Legislature of the National Assembly and functioned as the sole Legislative Power for the whole term.

After the general election of the Second Legislature of the National Assembly, on July 26, 1998, Cambodia experienced a political crisis. In order to solve hat crisis, a Summit of high ranking leaders from the two main political parties—Cambodian People's Party and FUNCINPEC—was held on November 12-13, 1999 at he Royal Palace's Khemrim Pavilion under the supreme chairmanship of His Majesty Norodom Sihanouk, who was then the King of the Kingdom of Cambodia.

According to the result of the Summit, the Senate was established and became part of the national Legislative Body with two Chambers following the amendment of the 1993 Constitution.

The first legislature of the Senate was created with appointment of a five-year term. Sixty one senators were selected from among the high dignitaries of the political parties occupying the seats of the second-legislature of the National Assembly. The first legislature of the Senate convened its first session on March 25, 1999.

The second Legislature of the Senate was established by a non-universal election on Sunday January 22, 2006 with a six-year term. Among the 61 senators, 57 were directly elected through a non-universal election, two were appointed by the National Assembly and two by His Majesty the King. The Senate of the second legislature opened its first session on March 20, 2006.

#### II- TEN-YEAR ACHIEVEMENTS OF THE SENATE

The Senate has three important functions: Legislation, Representation and Oversight. In particular, the Specialized Commissions assumes the duty of legislative, information-seeking and oversight.

For the past ten years, the Senate has actively fulfilled its duty resulting in the following achievements:

#### 1- Legislative Function

In its legislative function, the Senate has reviewed and provided recommendations to draft legislations and issues referred to the Senate. Actually, for the past ten years, the Senate has reviewed 205 text legislations out of the 228 text legislations referred to by the National

## Assembly.

## a- Plenary Sessions and Extraordinary Sessions

For the first legislature (1999-2005): The Senate had twice extended its term for a period of one year each. The Senate convened 10 plenary sessions; called on 90 meetings and 4 extraordinary meetings to review and make recommendation to 128 text legislations. Out of the 128, the Senate proposed the National Assembly to amend two text laws:

- 1- Law on the establishment of the Ministry of Women and Veteran's Affairs
- 2- Law on Management of Private Professional Practice in Medical Sciences, Medical Support and Medical Assistance.

In a different occasion, the Senate refused to accept and review the text legislation on Criminal Offenses

For the second legislature (2006-2012)- up to January 2009: The Senate had convened five plenary sessions; called on 29 meetings and 04 extraordinary meetings to review and make recommendations to 77 text legislations, out of the 91 referred to by the National Assembly.

In implementing its role and duty, the Permanent Committee has called on 131 meetings to prepare the legislative agendas and schedules, fixing the dates for the Senate sessions (plenary and extraordinary), select the secretaries for each session and meeting and to review and decide on the Internal affairs of the Senate.

# d- Activities of the Nine Specialized Commissions

The nine specialized commissions have been working actively according to their respective role, duty and competence which enables each of them to play a role as a Mini-Senate in order to realize the three main functions.

For the past ten years, the nine specialized commissions have reviewed and debated on proposals, draft laws and complaints resulting in the following description:

 The Human Rights and Complaints Commission have received, investigated, resolved and referred 1,171 cases to competent authority, and reviewed two text legislations.

- The Commission on Finance, Banking and Audit has taken part in dispute resolution and referred 10 cases to the competent authority, reviewed 51 text legislations.
- The Commission on Economy, Planning, Investment,
   Agriculture, Water Resources, Meteorology, Rural Development and
   Environment has taken part in dispute resolution and referred 98 cases
   to competent authority, and reviewed 34 text legislations.
- The Commission on Interior, National Defense, Parliamentary Relations and Inspection, and Public Functions has taken part in dispute resolution and referred 669 cases to competent authority, and reviewed 15 text legislations.
- The Commission on Foreign Affairs, International Cooperation,
   Information and Media has taken part in dispute resolution and referred
   37 cases to competent authority, and reviewed 26 text legislations.
- The Commission on Legislation and Justice has taken part in dispute resolution and referred 435 cases to competent authority, and reviewed 31 text legislations.
- The Commission on Education, Youth and Sports, Cults,
   Religion and Culture, and Tourism has taken part in dispute resolution
   and referred 38 cases to competent authority, and reviewed 07 text
   legislations.
  - -The Commission on Health, Social Affairs, Veteran Affairs,

Youth Rehabilitation, Employment, Vocational Training and Women's Affairs has taken part in dispute resolution and referred 12 cases to competent authority, and reviewed 12 text legislations.

- The Commission on Public Works, Transportation, Civil Aviation, Telecommunication, Post, Industry, Mines, Energy, Trade, Land Management, Urbanization and Construction has taken part in dispute resolution and referred 75 cases to competent authority, and reviewed 27 text legislations.

## e- Special Commissions of the Senate

Besides the nine specialized commissions mentioned above, the Senate has created six other special Commissions:

- Special Commission in charge of drafting the Internal Rules of Procedure of the Senate
- Special Commission in charge of creation of the Coat-of Arm and Uniform for Senator
- Special Commission in charge of drafting the proposed amendment to the Internal Rules of Procedure of the Senate
- Special Commission in charge of review of the proposed

  Decoration for Senators at the end of the legislature and Mid Second
  legislature
- Special Commission in charge of drafting the proposed amendment to the 1999 Internal Rules of Procedure of the Senate
- Special Commission in charge of drafting the proposal law on the Statute of Senators

#### 2- Representation Function

In implementing this representation function, the Senate has organized seven regional forums with 1,021 participants who are Commune/Sangkat Council members, the detail of which is described below:

- Forum on Decentralization and Deconcentration and representation of interest of Commune/Sangkat Councils in Banteay
   Meanchey province, held on July 5, 2007 with total participants of 160 including 66 representatives from all Commune Councils of Region 4.
- Forum on Decentralization and Deconcentration and representation of interest of Commune/Sangkat Councils in Koh Kong province, held on September 25, 2007 with total participants of 247 including 55 representatives from all Commune Councils of Region 7.
- Forum on Human Rights and Compliance to the law at the locality, Decentralization and Deconcentration and representation of interest of Commune/Sangkat Councils in Phnom Penh Capital, held on December 7, 2007 with total participants of 209 including 76 representatives from all Commune Councils of Region 1.
- Forum on Decentralization and Deconcentration and representation of interest of Commune/Sangkat Councils in Svay Rieng province, held on January 24, 2008 with total participants of 337 including 216 representatives from all Commune Councils of Region 6.
- Forum on Decentralization and Deconcentration and representation of interest of Commune/Sangkat Councils in Kampot

province, held on March 31, 2008 with total participants of 268 including 127 representatives from all Commune Councils of Region 5.

- Forum on promotion of interest of Commune/Sangkat in the implementation of Decentralization and Deconcentration policies in Phnom Penh Capital, held on November 03, 2008 with total participants of 204 including 66 representatives from all Commune Councils of Region 1.
- Forum on Decentralization and Deconcentration and representation of interest of Commune/Sangkat Councils in Kandal province, held on December 15, 2008 with total participants of 347 including 193 representatives from all Commune Councils of Region 3.
- Forum on Decentralization and Deconcentration and representation of interest of Commune/Sangkat Councils in Kampong Cham province, held on February 03-4, 2008 with total participants of 324 including 222 representatives from all Commune Councils of Region 2.

In organizing the forums down to the communes, the aim is to make the Senate closer to the local level and to illustrate clearer of the representation of the interest of the communes/Sangkats within the framework of the eight regions in Cambodia.

All forums have been successfully organized, thanks to the good cooperation between the Secretariat General of the Senate and the National League of Commune/Sangkat with support from UNDP, EU, Konrad Adenauer Foundation and various generous people.

From the day of its establishment, the leaders of the Senate, Permanent

Committee, Commissions and Senators have conducted 9,804 visits to the localities and helped solve many different issues.

#### 3- Oversight Function

#### a- The Nine Specialized Commissions

All the nine specialized commissions have conducted 143 visits to the provinces and cities to monitor the compliance of laws and policies in all fields at the localities.

#### b- The Female Senator's Group

Female Senators and Women working at the Secretariat General of the Senate have conducted 47 visits and organized get-together and talks with Women Councilors in the eight regions. In addition, the Female Senator's Group organized the first Forum on "Promoting the Role of Women's Councilors in order to take part in local Development" in Koh Kong province, held on 19-20 February 2009 with 165 participants including 76 Women Councilors from Region 7.

#### 4- Information-seeking Function

The Senate has assigned delegations of Commission and Senators to the localities to do a fact-finding mission to see the status of economic, social, religious, environmental situation and the need of local people.

## 5- Public Relations and International Cooperation Function

#### a- Public Relations

For the past ten years, the leaders of the Senate have engaged in 1,610

times of talks and audiences with national and international guests and other ceremonies as described below:

- Samdech Akka Moha Thamma Pothisal Chea Sim, President of the Senate, a total of 932 times
- Samdech Sisovath Chivanmonirak, First Vice President, a total of 454 times
- H.E. Tep Ngorn, Second Vice President, total of 175 times
- H.E. Nhek Bun Chhay, Former Second Vice President, a total of 28 times
- H.E. Por Bun Sroeu, Former Second Vice President, a total of 21 times

#### b- International Cooperation

Since 1999 the Senate has always considered international cooperation as the core strength for its institutional development. In fact, the Senate has increased good cooperation with Parliaments of friendly countries through the creation of Friendship Groups and Membership in InterParliamentary Union (IPU), ASEAN InterParliamentary Association, Association of French-speaking Parliaments, etc. Furthermore, the Senate has strengthened its long-term cooperation with the United Nations Development Program (UNDP), the Konrad Adenauer Foundation (KAF), Canadian International Development Agency (CIDA) through Cambodia-Canada Legislative Support Project (CCLSP), The Asia Foundation and other International Partners. Particularly, the governments of Japan, China, and Vietnam, the French, Canadian and Australian

Parliaments, and the National Assembly of the Republic of Korea have actively taken part in helping the Senate of Cambodia.

#### c- Exchange of High Ranking Parliamentary Delegations

In order to strengthen the ties of solidarity and good cooperation in all fields, and to make the relationship closer between countries, peoples and Parliaments among countries, the High-Ranking delegation of the Senate led by Samdech Akka Moha Thamma Pothisal Chea Sim, President of the Senate has paid official visit to Japan, People's Republic of China, Socialist Republic of Vietnam, and Lao People's Democratic Republic.

During the same period, high-ranking parliamentary delegations from different countries have paid official visit at the Senate such as delegations led by the Presidents of the Senate of France, Belgium, Australia, Canada, and the Chinese People's Political Consultative Conference.

On the other hand, the Cambodian Senate has sent numerous delegations for official visits, study visits, meetings, conferences and seminars with a total of 211 persons, and have received foreign delegations who have come for visits and meetings in Cambodia for a total of 412 times.

## d- International Cooperation Outcome

Since its establishment in 1999, the Senate has been receiving institutional development aid from governments and parliaments of friendly countries in the total amount of USD 4,804,123.16 which includes:

An amount of USD 3,242,921 from the government of the People's

Republic of China for the renovation of the Senate Plenary Session Hall, and Construction of the Senate Library, Offices of Senators, restoration of the infrastructure of the Senate, the cost of computers and vehicles.

- An amount USD 1,325,702.16 from the Royal Government of Japan for the renovation of old buildings, office equipments and materials, and the equipment in the Senate Studio.
- In-kind assistance worth of USD 155,000 from the government of the Socialist Republic of Vietnam for the office supplies and equipment, and floor carpet.
- The National Assembly and the government of the Republic of Korea has provided computers worth of USD 28,600, and a number of filing cabinets and one vehicle.
- The Senate and the government of France and the Assemblée Parliamentaire Francophone (APF) have provided computers, printers and scanners worth of USD 31,900.
- The government of the Brunei Darussalam has provided in-kind assistance worth of USD 20,000.
- The government of Indonesia has provided furniture equipped in the main Reception Hall of the Senate.

Within the framework of cooperation and partnership with local and international partners, the Senate has organized 105 forums, seminars, roundtable discussions with topics related to the functioning and institutional development of the Senate.





#### 6- Activities of the General Secretariat of the Senate

The Secretariat General of the Senate functions its role as the core pillar of the Senate to ensure all works related to administration, finance, security and other services to the Senate, and internal and external relations.

### a-Management Principles of the General Secretariat

The Secretariat General of the Senate implements its management mechanism through democratic, open and transparent principles. In general, in the process of developing any standard instructions and policies in serving the guidance and management, the responsibility in doing so is given to a Committee with mixed composition of officials from all units attached to the Secretariat General who have professional working experiences.

In implementing the Law on the Statute of the Legislative Civil Servants, a number of urgent provisions have been established to serve the necessity in the leadership and management of human resource, and to take into consideration the interests of the civil servants in order to guarantee the sustainable institutional development as well to integrate officials governed by the old Statute into the new Statute.

In the institutional development, the Secretariat General of the Senate has created the following basic documents:

- Five-Year Strategic Plan (2003-2008) with the following strategic goals:
  - Human resource management and development

- Structure of systematic policy and management procedure
- · Information Technology system
- Information dissemination
- Public relations between national and international institutions
- Strategic Framework and ten-year activity plan for capacity strengthening of the Senate (2008-2018) which is divided as follow:
  - 1. Short-term activity plan (2008-2009) which focuses on:
    - Strengthening the role of the Senate
    - · Human resource and institutional development
  - Mid-term activity plan (2010-1013) which focuses on:
    - · Training of new Senators
    - · Procedure to review text laws or proposals
    - Participation of the Parliament in the legislative process at the initial stage
    - Strategic planning at Specialized Commission level
    - Strengthening the role in budget development and monitoring, and the ability to monitor the socio-economic and cultural evolution
    - · Strengthening public relations
    - Representational the role of the Senate
    - General training program
  - 3. Long-term activity plan (2014-1018) which focuses on:
    - The establishment of Parliamentary Center
    - Continuation of strengthening the role of developing budget and monitoring, socio-economic and cultural evolution.
    - Development of Audit Capacity

· Guarantee the representation capacity of the Senate

Along with this, all units under the Secretariat General have developed a five-year strategic plan which corresponds to the Strategic Framework and the Ten-year Capacity Strengthening Plan of the Senate (2008-2018).

Under the framework of cooperation between the National Assembly, both Secretariats General of the Parliament (Senate and National Assembly) have developed a Strategic Framework and a Ten-year Activity Plan (2008-2018) to strengthen the capacity of the Cambodian Parliament which serves as a road-map for the process of development of the Senate and the National Assembly.

Under the cooperation with the United Nations Development Program (UNDP), the Secretariat General of the Senate has developed a number of master plans for the following institutional development:

- •Master plan for capacity development in legal field
- ·Master plan for development of Library and Archives
- •Master plan for development of Information Technology (IT)
- Master plan for development of communications
- Master plan for development of human resource.

The Secretariat General of the Senate established and implemented six joint decisions (Senate-National Assembly- Constitutional Council) and eight policies as described below:

### b- In-country and International Training of Human Resource

Based on assistance from national and international partners, the Secretariat General of the Senate has been putting lots of efforts to increase the capacity of its staff. Since 1999, the Secretariat General has conducted 259 sessions of in-country and international trainings for its staff and officials.

### 1- In-country Training

Conducted 248 sessions of in-country training with the goal to strengthen capacity in administration skill, socio-economic research, human rights, library management, Khmer stenography, secretarial, media, legislative drafting code of international law, information technology, foreign languages, etc.


### c- Infrastructure Development of the Senate

Since 1999, the Senate has repaired and renovated buildings, the path system, gardens, gates, running water system, sewage system, wiring system within the premise of the Senate. ### III- Ten-Year Vision of the Senate

Strengthening the capacity of the Senate of Cambodia is an important contribution for the success of the country in developing and strengthening democracy, rule of law, socio-economic development, and the concretization of integration of Cambodia into regional and international framework. In order to realize this prospect:

- The Senate must function according to the working standard of parliament in democracy and must be the good partner of regional and international democratic parliaments.
- The Senate must fulfill its primary role as the representative of Commune Councils throughout the country and must act as the driving force to ensure successful implementation of the decentralization and deconcentration policy of the State and the all-sided development of the commune/Sangkat council.
- Members of the Senate must concretize their legislative, representational and oversight functions.
- The Specialized Commissions of the Senate must concretize their legislative, oversight and information-seeking function according to their role as a real Mini-Senate.
- The Secretariat General of the Senate must have the capacity to provide full-scale services in every expertise to the Institution, the nine specialized commissions and Senators according to the administrative system of modern parliaments and equip itself with modern IT system.
- Officials working at the Secretariat General must have high level of education, expertise, foreign language in order to be able to deliver necessary, efficient and quality services.

In this regards, the Senate must have a mechanism which constitutes a

potential as a core pillar by establishing the Legal Center, Information Center, Center for Budget Development and Monitoring, Center for Socio-Economic, Cultural and Environmental Research.

### CONCLUSION

So far since its first term, the Senate has really been contributing to national development in all fields with good judgment and accountability, and actively taking part in strengthening good governance, rule of law, and the implementation of local democracy.

For the past ten years, the Senate of the Kingdom of Cambodia has fulfilled its role and duty under the name of legislative institution with more and more maturity resulting in positive achievements in its three functions.
